Entrants are asked to find as many sponsors as possible who will agree to pay a given sum of money for every church or chapel visited, or per mile covered, or indeed any other unit of counting you care to devise. Sponsorship money could also be raised by helpers – being sponsored for each hour they sit in the church, or by the number of cups of tea they make, or in any other way you can think of. The sponsorship will cover the one day, Saturday 10th September, between 9.00am and 5.00pm.

Instructions to participants

Enter your details on the Welcome Poster at the church. Some churches will have toilet facilities and refreshments available – see 'The Guide to Open Churches' which will be published in August.

The County Treasurer should receive all your monies together with this form as soon as possible but in any event by the end of October (any cheques should be made payable to Devon Historic Churches Trust). Half the amount you raise will be sent to the church or chapel you have nominated.

Safety First

Please observe the Countryside and Highway Codes and, if cycling, please ensure that your cycle is roadworthy. If you ride in a group, please ride single file. However, all entrants take part at their own risk – it is a condition of entry that the organisers and the Trustees of Devon Historic Churches Trust accept no liability in respect of death or injury sustained by anyone participating in the Devon Historic Churches Ride & Stride event.

Rules for Gift Aid

By ticking the box I confirm that I have paid or will pay an amount of Income Tax and/ or Capital Gains Tax for each tax year (6 April to 5 April) that is at least equal to the amount of tax that all the charities or Community Amateur Sports Clubs (CASCs) that I donate to will reclaim on my gifts for that tax year. I understand that other taxes such as VAT and Council Tax do not qualify. I understand that the DHCT will reclaim 28p of tax on every £1 that I gave up to 5 April 2008 and will reclaim 25p of tax on every £1 that I give on or after 6 April 2008. I would like the Devon Historic Churches Trust to treat all donations I make from this date of declaration as Gift Aid donations, unless I notify you otherwise. Please notify us of any change of address and/or circumstance.
